The U.S. competition received 1,180 contributions in five categories, including 818 general images, 66 images of people in science, 213 microscopy images, 47 non-photographic submissions, and 36 image sets containing 184 images. The jury selected five submissions as "Jury's Choice" awards, each of which received a \$200 prize from Wikimedia DC.
