We request penalty relief for late filing on this return. (1) Our organization's president, vice president, and treasurer are new in their roles as of January 2022. We learned that the former officers had mistakenly not filed form 990s for multiple years. Furthermore, the IRS appears to have had on file an incorrect, old physical address that we do not receive mail at, which we only discovered when talking to our Taxpayer Advocate, so the officers were unable to learn of their mistake through communications from the IRS. These circumstances were the result of unintentional, innocent error and not the result of willful neglect. (2) During the intervening period, we continued to exercise ordinary business care and prudence by operating according to our charitable purpose and in compliance with the requirements of a 501(c)(3) organization. Our major activities did not change during this period. During this time we continued to keep thorough financial records, and published our annual financial reports each year in a timely manner on our website. (3) Upon being made aware of this issue, the current officers, new in our positions as of 2022, began to prepare the missing form 990s. We were new to filing form 990s and did not want to make mistakes, so we sought expert advice and documentation to help us, including engaging the Taxpayer Advocate Service. At this time we have completed filing them for all outstanding years. (4) We have taken steps to prevent this problem in the future by filing a form 8822-B to correct our mailing address, and by establishing procedures to file future form 990s in a timely manner. Until 2022, only one officer had filed tax forms; now three officers have contributed to filling out the outstanding returns, and our distribution of skills and capabilities now means we will be safer from over-dependence on one person. We believe we are well-positioned to avoid falling behind in the future.
